Except as provided in Sections 6254.7 and 6254.13, this chapter does not require the disclosure of any of the following records: (a) Preliminary drafts, notes, or interagency or intra-agency memoranda that are not retained by the public agency in the ordinary course of business, if the public interest in withholding those records clearly outweighs the public interest in disclosure.
